SECTION 4: FIRST AID MEASURES

Skin Exposure:	In case of contact, immediately wash skin with soap and copious amounts of water. If irritation persists, call a physician.
Eye Exposure:	Separate the eyelids and thoroughly rinse the skin with running water. Seek medical attention immediately.
Inhalation Exposure:	If inhal, remove to fresh air. If necessary, get medical attention.

SECTION 5: FIRE FIGHTING MEASURES

Hazardous characteristic:	Not flammable and dangerous goods.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Emergency treatment:	Use personal protective equipment. Ensure adequate ventilation. Avoid inhaling dust. Remove all ignition sources. Make sure personnel are away from or upwind of the leak area. No entry for irrelevant personnel. Collect with a cleaning shovel in a dry, clean, covered container for disposal. Avoid dust. Ventilate and spray after cleaning.
Environmental protection measures:	Prevent the release of chemicals into the environment. If they leak into the drainage system or aquatic environment, notify the local authorities. Under the condition of ensuring safety, take measures to prevent further leakage or spillage. Prevent the leakage substances from entering sewers, surface water and groundwater. If it directly affects the drinking water environment of nearby residents, notify the nearby residents to temporarily refrain from using drinking water resources.

SECTION 7: HANDLING AND STORAGE

Handling precautions:	Operators should undergo training and strictly follow the operating procedures. It is recommended that operators wear general work protective clothing and appropriate chemical protective gloves. Dust should be avoided. Inhalation should be prevented. Direct contact with the eyes and skin should be avoided. Keep away from fire sources, heat sources, and smoking is strictly prohibited in the workplace. There should be ventilation systems and equipment in the workplace. Avoid contact with strong acids, strong bases, and oxidants. After the operation, thoroughly wash hands and face. When handling, do so gently to prevent the packaging from breaking and getting damp. Equip with corresponding types and quantities of fire-fighting equipment and leak emergency handling devices.
