Hazardous characteristic:	Not flammable and dangerous goods.
Fire extinguishing method and agent:	The product is flammable, need combined with the surrounding environment and the situation at that time to confirm suitable fire extinguisher.
Fire extinguishing measure:	Firefighters should wear self-contained positive pressure breathing apparatus and wear fire protective clothing to prevent skin and eye contact. Put out the fire upwind. Evacuate all personnel to a safe area. Remove all ignition sources if possible.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Emergency treatment:	Use personal protective equipment. Ensure adequate ventilation. Avoid inhaling dust. Remove all ignition sources. Make sure personnel are away from or upwind of the leak area. No entry for irrelevant personnel. Collect with a cleaning shovel in a dry, clean, covered container for disposal. Avoid dust. Ventilate and spray after cleaning.
Environmental protection measures:	Avoid releasing chemicals into the environment. In case of leakage into the drainage system/aquatic environment, local authorities should be notified. Environmental protection measures: Measures are taken to prevent further leaks or spills while ensuring safety. Prevent spills from entering sewers, surface water and groundwater. If it directly affects the drinking water environment of nearby residents, nearby residents should be notified not to use drinking water resources for the time being.
